Waiver and release of liability. READ CAREFULLY.

In consideration of Sweet Valley Cottages furnishing services and/or equipment to enable me to participate in boating, fishing and swimming activities, I agree as follows:

I fully understand and acknowledge that outdoor recreational activities have: (a) inherent risks, dangers and hazards; and such exist in my use of boating equipment and my participation in boating, fishing and swimming activities; (b) my participation in such activities and/or use of such equipment may result in injury or illness including, but not limited to, bodily injury, disease, strains, fractures, partial or total paralysis, death or other ailments that could cause serious disability; (c) these risks and dangers may be caused by the negligence of the owners, employees, officers, agents or volunteers of Sweet Valley Cottages, the negligence of the participants, the negligence of others, accidents, breaches of contract, the forces of nature or other causes. Risks and dangers may arise from foreseeable or unforeseeable causes including, but not limited to, terrain, weather, wind, trail, water level, risks of falling out of or drowning while in a boat, on a bridge, dock, or along the shoreline and such other risks, hazards and dangers that are integral to recreational activities that take place in a wilderness, outdoor or recreational environment; and (d) by my participation in these activities and/or use of equipment, I hereby assume all risks and dangers and all responsibility for any losses and/or damages, whether caused in whole or part by the negligence or other conduct of the owners, agents, employees, officers, agents, or volunteers of Sweet Valley Cottages. or by any other person.

I, on behalf of myself, my personal representatives, and my heirs, hereby voluntarily agree to release, waive, discharge, hold harmless, defend and indemnify Sweet Valley Cottages and its owners, agents, officers, employees or volunteers from any and all claims, actions or losses for bodily injury, property damage, wrongful death, loss of services or otherwise which may arise out of my use of boating equipment or my participation in boating, swimming and lake activities. I specifically understand that I am releasing, discharging and waiving any claims or actions that I may have presently or in the future for the negligent acts or other conduct of the owners, agents, officers, employees or volunteers of Sweet Valley Cottages.

I have read the above waiver and release and by signing it agree. It is my intention to exempt and relieve Sweet Valley Cottages from liability for personal injury, property damage or wrongful death caused by negligence or any other cause.
